I. Executive Summary

 - 3. To gather information on undergraduate readmissions and allied issues and assess university performance in these areas in light of the information obtained.
 - 4. To propose changes in university policy and procedures on undergraduate readmissions and allied issues.
 - 5. To handle any propass the committee may make affecting university policy according to the section C.2 "Shared Governance Procedure for Policy Change Recommendations."
 - 6. To submit a final written report electronically by the first day of fall semester to the Provost and Execut/ice President for Academic Affairs with a copy sent to the Chair of the SGEC.
- III. The Committee met on the following dates: August 15, 2022 and January 9, 2023
- IV. What were the Committee's actions and accomplishments this year relative to each of the items of the charge?
 - 1. The committee served as a board of appeal for undergraduate readmissions as listed in the committee charge. The committee acted in an advisory capacity to students who appeared before the committee in terms of credit hour enrollmentsparticipation in counseling services and other University services. The committee heardfive appeals from students ith more than one academic suspension. Of the fistedents who appealed, one was denied (both for fall and spring semesters; two of the fistepeals) and there were readmitted. The student who was denied twice had, in the August meeting, been advised of a expression suspension but chose to resubmit for the spring 2023 term anyway. The committee continued with

a short interview of canidates and intends to continue this practice going forward as it allows students an opportunity to expand on the answers given on the application. (Items 1 through 3 in the Committee's charge.)

- 2. The committee did not make proposals that would affect ite**ans**d45 of the charge. This report will fulfill item 6.
